GUIDELINES - MBBS ADMISSIONS UNDER NRI QUOTA

General:

- The provisions contained in this set of regulations govern the policies and procedures on the admission of students into MBBS course.
- This set of regulations shall be in addition to Convenor, EAMCET-2016 and Kaloji Narayana Rao University of Health Sciences (KNRUHS) and Medical Council of India (MCI) stipulated with all the amendments thereto, and shall be binding on all students seeking admission into the Under Graduate program. In order to guarantee fairness and justice to all the parties concerned, any specific issues or matters of concern shall be addressed separately, by the appropriate authorities, as and when found necessary.
- These regulations can also be downloaded along with the Application Form.
- Application form will be available in the Office of the Principal, Malla Reddy Institute
 of Medical Sciences (MRIMS), Suraram Main Road, Jeedimetla, Hyderabad from
 10:00 AM on 19th September 2016 to 4:00 PM on 21st September 2016.

Intake:

- Total M.B.B.S 150 seats
- Category C (NRI) Seats 15% of total intake

Eligibility Criteria:

- The candidates should be Indian Nationals and should satisfy Local, Non-Local status requirement as laid down in the Telangana Educational Institutions (Regulation of Admission) Order, 1974. Selection will be done as per the procedure laid down in the G.O. P.No.646 dated 10.07.1979 as amended in G.O.Ms.No.42, Higher Education (EC2) Dept, dated 18.05.2009.
- Applicant should be supported financially by an NRI who must be a blood relative such as father / mother / brother / sister / uncle / aunt only.
- Candidates should have completed the age of 17 years on or before 31st December of
 the year of admission and shall not have completed 21 years of age as on the 1st July
 of that respective academic year.

• The candidate should pass two years intermediate examination (10+2) pattern or equivalent examination with Physics, Chemistry, Botany, Zoology and English. Candidates should obtain a minimum of 50% marks in science subjects.

The Application Procedure:

- Eligible and National Eligibility cum Entrance Test (NEET) qualified candidates should submit the application duly filled-in as per the prescribed format which can be downloaded from the college website or drawn from the college office in person.
- Candidates should specifically mention that he/she is applying seat under NRI Quota.
- The candidate applying for admission if found eligible under applied category will be required to appear before Selection / Counseling Board of interview at their own expenses at the college on a date and time fixed by the college.
- Selection of candidates in all the categories shall be subject to production and verification of all the relevant certificates in original.
- No intimation what so ever about selection will be sent individually and no correspondence in this regard shall be entertained. The result will, however, be available in the office of the college principal for information and perusal of the candidate. The result will also be available on the college website & notice board of the college.
- The Selection Board shall have the power to review the provisional selection in case of any bonafide error or lapse or mistake or fraud, misrepresentation or glaring injustice that occurs or is brought to its notice before completion of the selection process or after the selection / admission process and the selection list shall be amended accordingly. Mere figuring in the selection list will not confer any right to admission of the candidate if he / she is otherwise found ineligible on detection of such error / mistake / fraud / misrepresentation / impersonation etc.
- Applications can be obtained personally from the college / downloaded from the college website. Duly filled-in application to be submitted personally in the college office before the last date and time.

Selection Procedure:

• The college office will scrutinize all applications received and registered on or before the time & date set for submitting the applications and prepare the merit list

of candidates on the basis of individual's rank obtained in NEET exam. Merit list contained the names of the candidates as per the order of merit will be prepared and displayed on the notice board and website of the college.

- The candidates whose names appear in the merit list referred to above shall appear before the Interview / Counseling Board on a date and time fixed by the college. The date and time for interview / counseling will be displayed on the website and notice board of the college. The candidate should physically attend the interview. No proxy will be entertained.
- Candidates called for counseling / interview shall submit all original certificates,
 Bank Guarantee, Bonds, College Tuition Fee (by demand draft payable to the
 Principal, Malla Reddy Institute of Medical Sciences, Suraram) to the college office
 three hours before the interview time. Only those candidates who have submitted
 original documents, bonds, bank guarantee and tuition fee will be eligible to appear
 before the interview / counseling board.
- The college interview / counseling board will scrutinize the applications and the documents submitted by the candidates and determine the inter se merit of the candidate.
- Final list of candidates selected for admission under management quota will be prepared and displayed on the website and notice board of the college. A final merit list thus prepared will be sent to KNRUHS for approval.
- The college will admit candidates from the merit list approved by KNRUHS.

Bonds:

Bonds listed hereunder should be submitted at the time of Interview. The format of the bonds is given in annexure I to IV.

- Bank Guarantee
- Study Bonds to KNRUHS
- Service Bonds to Government and to MRIMS
- Code of Conduct and Anti Ragging Affidavit

Joining Time:

• The selected candidates shall join the college within the specified date. If any candidate fails to report to the Principal on or before the date specified by the

college authority at the time of counseling the admission granted shall be cancelled automatically without any further notice and no further claims will be entertained under any circumstances. The candidates will forfeit the tuition fee paid to the college for the academic year 2016-17.

Applications are liable to be rejected in the following situations:

- Candidates who fail to fulfill the age criteria.
- Candidates who fail to obtain the minimum stipulated marks in the qualifying examination (Higher Secondary or +2)
- Faulty submissions with incomplete details in the forms will be rejected summarily.
- Submission of fake certificates.
